# Banner County

## DEMOGRAPHICS

### Population Estimates

The Census Bureau’s current census estimates indicate that Banner County’s population increased from 690 in 2010 to 798 in 2016, or by 15.7 percent. This compares to a statewide population change of 4.4 percent over the period. The number of people from 25 to 34 years of age increased by 41.2 percent, and the number of people from 55 to 64 years of age increased by 1.6 percent. The white population increased by 14.5 percent. The Hispanic population increased from 26 to 44 people between 2010 and 2016 or by 69.2 percent. These data are presented in Table II.4.1.

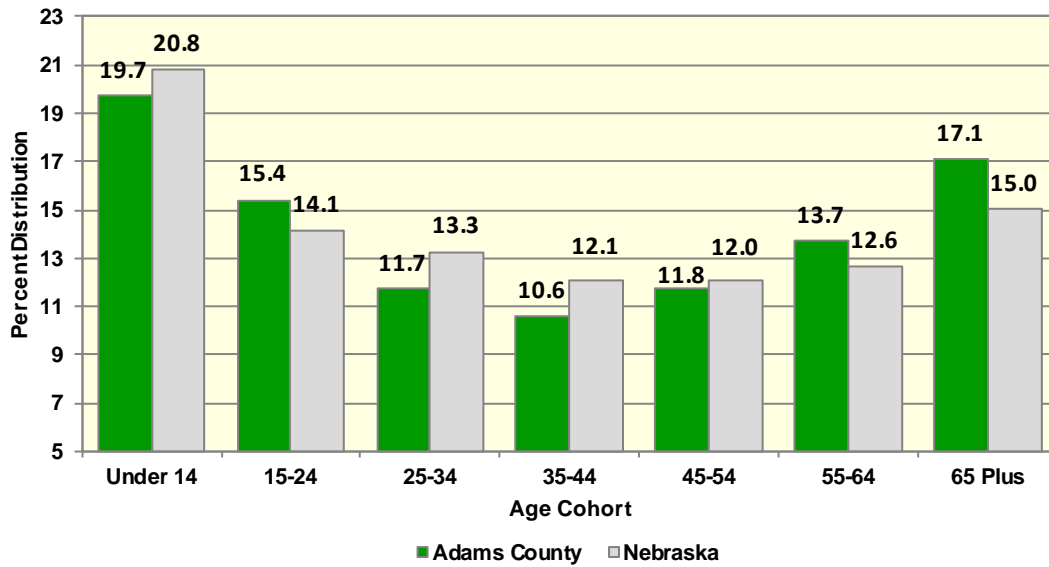

Table II.4.2, presents the population of Banner County by age and gender from the 2010 Census and 2016 current census estimates. The 2010 Census count showed a total of 354 males, who accounted for 51.3 percent of the population, and the remaining 48.7 percent, or 336 persons, were female. In 2016, the number of males was 398 persons, and accounted for 49.9 percent of the population, with the remaining 50.1 percent, or 400 persons being female.

### Population Migration Trends

Total population change is a combination of births, deaths, and the net migration of those arriving in and leaving the state. The result of births minus deaths is termed the “natural increase.” As calculated from data shown in Table II.4.3, from April 2000 to July 2009, Banner County natural increase was estimated to be 6 people. Banner County has been experiencing net out-migration, with 178 persons leaving the county in the last nine years.<sup>16</sup> The 2016 population estimates showed a natural increase of 9 persons. Between 2010 and 2016, Banner County’s population rose to 798 persons.

The Nebraska Department of Transportation (DOT)’s Department of Motor Vehicles provides another source of information about migration trends. These data represent the net of driver’s license exchanges: licenses issued to new residents of Nebraska and licenses surrendered to other states when Nebraska residents relocate to a new state. Known as the driver’s license exchange data, these records show that the net change in Banner County increased from 4 persons in 2015 to 13 persons in 2016, with an additional net movement of 2 in the first six months of 2017. The driver’s license total exchanges for the last 16 years are presented in Table II.4.4.

### School Age Enrollment

According to the Nebraska Department of Education (DOE), the total number of school-age children in Banner County decreased by 10.4 percent from 135 in 2016 to 121 in 2017, as shown in Table II.4.5. The number of school-age children 5 to 11 years of age decreased from 63 in 2016 to 60 in 2017.

### Census Demographic Data

In the 1980, 1990, and 2000 decennial censuses, the Census Bureau released several tabulations in addition to the full SF1 100 percent count data including the one-in-six SF3 sample. These additional samples, such as the SF3, asked supplementary questions regarding income and household attributes that were not asked in the 100 percent count. In the 2010 decennial census, the Census Bureau did not collect additional sample data, such as the SF3, and thus many important housing and income concepts are not available in the 2010 Census.

To study these important concepts the Census Bureau distributes the American Community Survey every year to a sample of the population and quantifies the results as one-, three- and five-year averages. The one-year sample only includes responses from the year the survey was implemented, while the five-year sample includes responses over a five-year period. Since the five-year estimates include more responses, the estimates can be tabulated down to the Census tract level, and considered more robust than the one or three year sample estimates.

### Population Characteristics

Table II.4.6, shows population by age for the 2000 and 2010 Census. The population changed by -15.8 percent overall between 2000 and 2010. Various age cohorts changed at different rates. The elderly population, or persons aged 65 or older, changed by 3.8 percent to a total of 136 persons in 2010. Those aged 25 to 34 changed by -23.9 percent, and those aged under 5 changed by -7.7 percent.

The elderly population is further explored in Table II.4.7. Those aged 65 to 66 changed by 52.9 percent between 2000 and 2010, resulting in a population of 26 persons. Those aged 85 or older changed by 11.1 percent during the same time period, and resulted in 10 persons over age 85 in 2010.

Population by race and ethnicity is shown in Table II.4.8 representing 95.7 percent of the white population in 2010. The black population changed by -100 percent, representing 0 percent of the population in 2010. The American Indian and Asian populations represented 0.4 and 0 percent, respectively, in 2010. As for ethnicity, the Hispanic population changed by -43.5 percent between 2000 and 2010, compared to the -14.1 percent growth rate for non-Hispanics.

## Disability

The disability rate from the 2000 Census is shown in Table II.4.15. Some 13.3 percent of the population was disabled in 2000, or a total of 104 persons. The disability rate was highest for those over 65, with 21.5 percent disabled.

## Education

Education and employment data, as estimated by the 2016 ACS, is presented in Table II.4.19 and Table II.4.21. In 2016, some 429 persons were employed and 34 were unemployed. This totaled a labor force of 463 persons. The unemployment rate for Banner County was estimated to be 7.3 in 2016.

### Labor Force

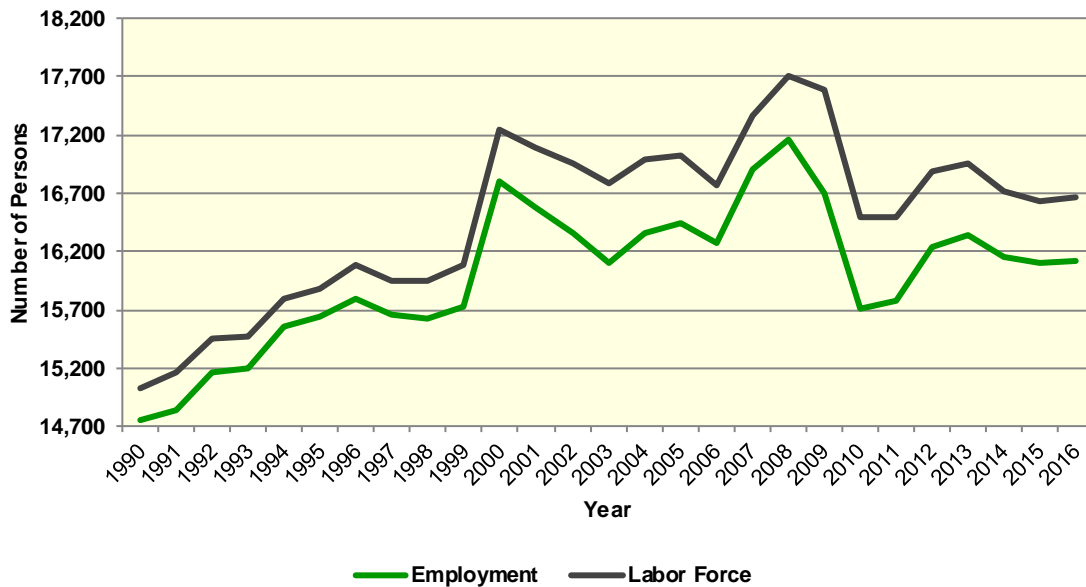
Table II.4.22, shows the labor force statistics for Banner County from 1990 to the present. Over the entire series the lowest unemployment rate occurred in 1990 with a rate of 1.2. The highest level of unemployment occurred during 2011 rising to a rate of 4.6. This compared to a statewide low of 2.3 in 1990 and statewide high of 4.6 in 2009. Over the last year the unemployment rate in Banner County increased from 3.4 percent in 2015 to 3.8 percent in 2016, which compared to a statewide increase to 3.2 percent.

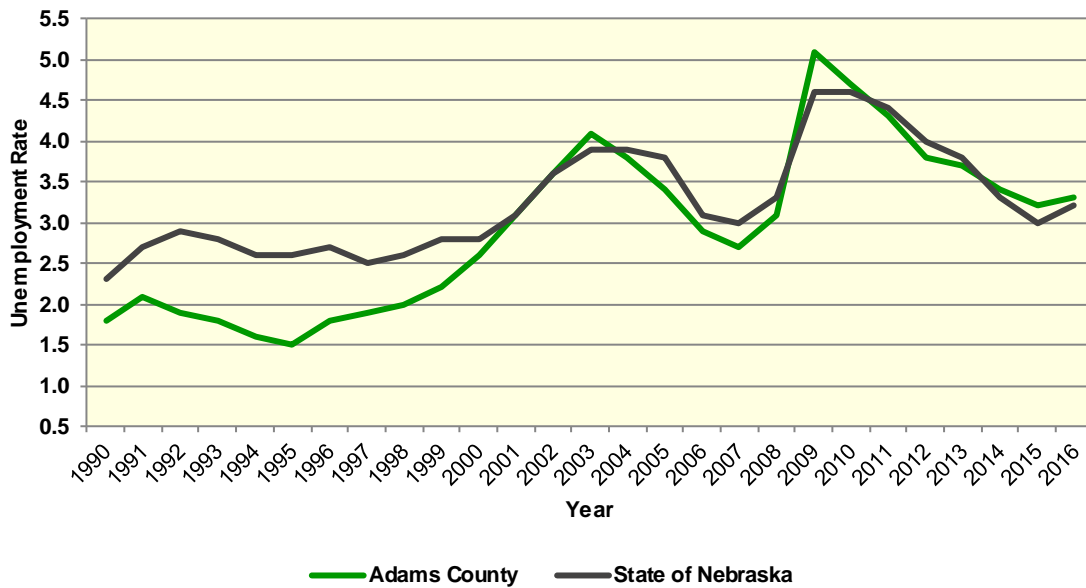
**Diagram II.4.2**

 BEA Data 1990 - 2016

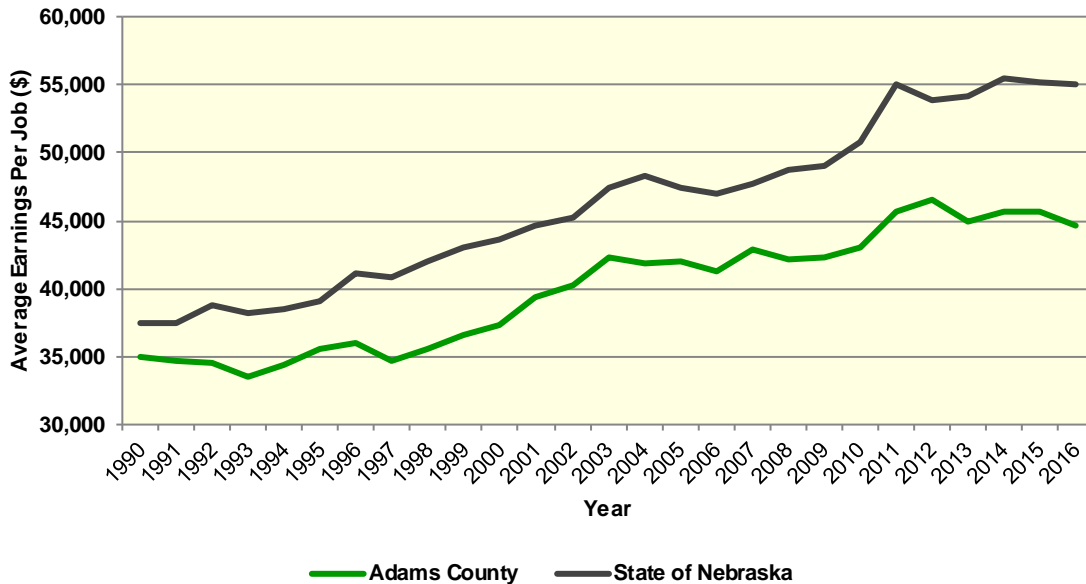
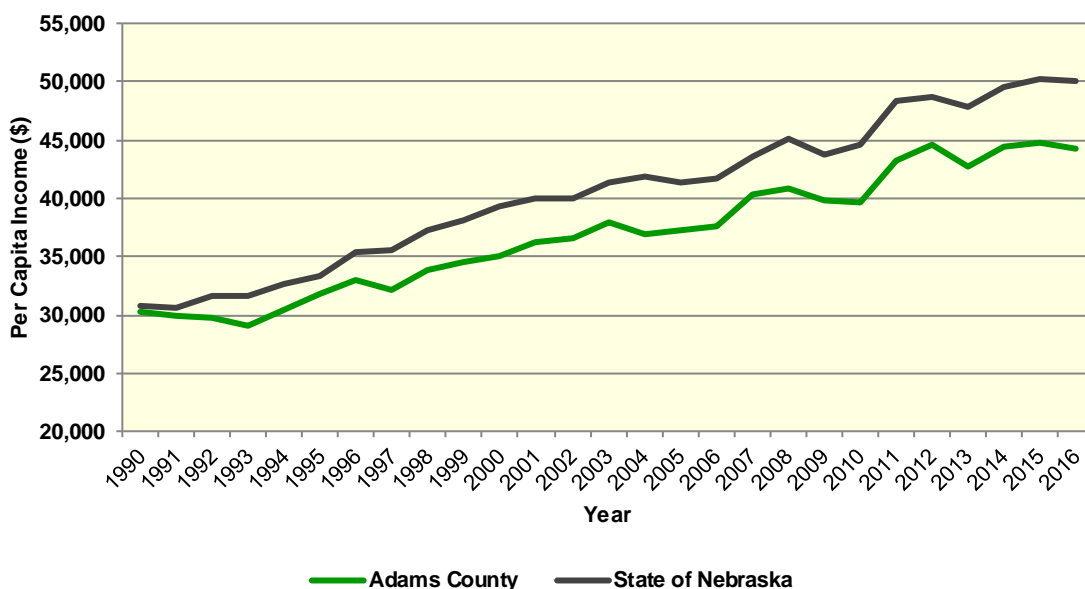

**Quarterly Census of Employment and Wages**

The Bureau of Labor Statistics (BLS) produces the Quarterly Census of Employment and Wages (QCEW), which reports monthly data on employment and quarterly data on wages and number of business establishments. QCEW employment data represent only filled jobs, whether full or part-time, temporary or permanent, by place of work the pay period. Data from this series are from the period of January 2006 through December 2016 and are presented in Table II.4.27 with the 2016 information considered preliminary. Between 2015 and 2016, total annual employment decreased from 154 persons in 2015 to 129 in 2016, a change of -16 percent.

## Poverty

Poverty is the condition of having insufficient resources or income. In its extreme form, poverty is a lack of basic human needs, such as adequate and healthy food, clothing, housing, water, and health services. According to the Census Bureau’s Small Area Income and Poverty Estimates Program, the number of individuals in poverty increase from 91 in 2010 to 100 in 2016, with the poverty rate reaching 12.5 percent in 2016. This compared to a state poverty rate of 11.3 percent and a national rate of 14 percent in 2016. Table II.4.31 presents poverty data for the county.

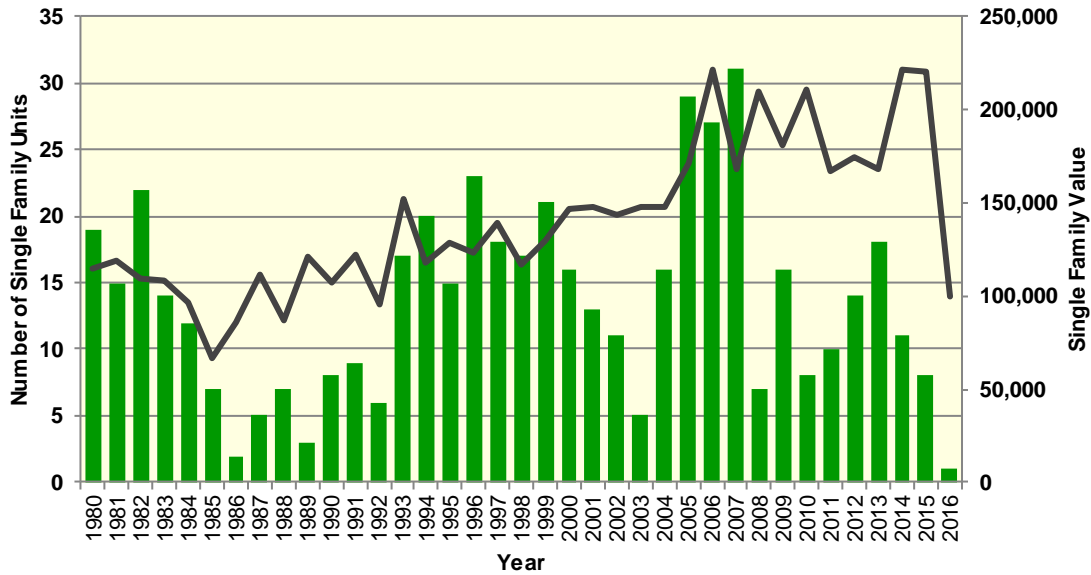

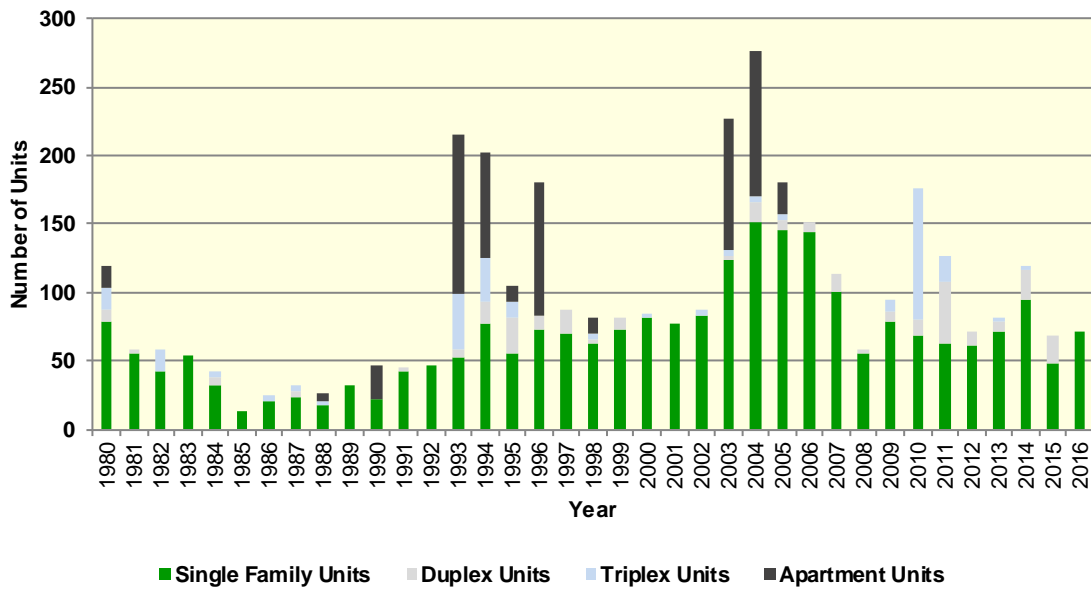

### Department of Property Assessment Division

**Housing Costs**

Between 2010 and 2017, the average price of an existing single-family home changed from \$101,000 to \$145,833, a total increase of 44.4 percent, as shown in Table II.4.46.

Single-family home prices from the PAD database also indicated a general increase in average home prices and average floor area for newer homes. The average home price for single-family homes in Banner County ranged from \$83,125 for homes built before 1930 to \$179,000 for homes built from 2001 to 2010.<sup>18</sup> Homes built from 2001 through 2010 were also larger, averaging 2,059 square feet per unit. Table II.4.47, provides additional details about single-family homes.

### Housing Problems

Households are classified as having housing problems if they face overcrowding, incomplete plumbing or kitchen facilities, or cost burdens. Overcrowding is defined as having from 1.1 to 1.5 people per room per residence, with severe overcrowding defined as having more than 1.5 people per room. Households with overcrowding are shown in Table II.4.48. In 2016, an estimated 1.3 percent of households were overcrowded, and an additional 0 percent were severely overcrowded.

Incomplete plumbing and kitchen facilities are another indicator of potential housing problems. According to the Census Bureau, a housing unit is classified as lacking complete plumbing facilities when any of the following are not present: piped hot and cold water, a flush toilet, and a bathtub or shower. Likewise, a unit is categorized as deficient when any of the following are missing from the kitchen: a sink with piped hot and cold water, a range or cook top and oven, and a refrigerator.

There were a total of 10 households with incomplete plumbing facilities in 2016, representing 3.2 percent of households in Banner County. This is compared to 0.6 percent of households lacking complete plumbing facilities in 2000.

Cost burden is defined as gross housing costs that range from 30.0 to 50.0 percent of gross household income; severe cost burden is defined as gross housing costs that exceed 50.0 percent of gross household income. For homeowners, gross housing costs include property taxes, insurance, energy payments, water and sewer service, and refuse collection. If the homeowner has a mortgage, the determination also includes principal and interest payments on the mortgage loan. For renters, this figure represents monthly rent and selected electricity and natural gas energy charges.

In Banner County, 9.9 percent of households had a cost burden and 8.9 percent had a severe cost burden. Some 10.4 percent of renters were cost burdened, and 19.8 percent were severely cost burdened. Owner-occupied households without a mortgage had a cost burden rate of 5 percent and a severe cost burden rate of 1 percent. Owner occupied households with a mortgage had a cost burden rate of 13.9 percent, and severe cost burden at 5.6 percent.

Table II.4.56 shows the total volume of owner-occupied single-family loans. In 2008, average home purchase loans was \$107,000 and \$ in 2012 and \$319,000 in 2016. Overall, average loans were \$267,000 in 2008 and \$779,000 in 2016.
